  - (a) Registration of Class II Examiners for e-workshop (email/ sms).

- (c) A question paper (multiple choice questions and short answer questions) shall be emailed at 0900h on 23 Nov 2013 to all Class II Examiners who register for the e-workshop. The Class II Examiners shall complete the answers and email it back by 1100h. The same shall be evaluated by the DMS (CA) subsequently.
- (d) Between 0900- 1200h, DMS (CA) would be available on email and Google messenger and shall answer specific queries that may arise on the topics of the workshop.
- (e) A certificate of participation shall be posted to the Class II Examiners who participate in the workshop.
- (f) A feedback form shall be sent by email to all participants who would be required to submit it back within 3 working days.
