**VACANCY CIRCULAR**

Applications through proper channel are invited from Indian Nationals for appointment to the post of Director General of Civil Aviation in the scale of pay of PB – 4 ` 37400 – 67000 with Grade Pay ` 12,000 in the Directorate General of Civil Aviation (Head Quarters), New Delhi on deputation basis.

2. The eligibility conditions as prescribed in the recruitment rules are given at Annexure A.

Note 1:- The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.

Note 2:- Period of deputation, including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of Central Government shall ordinarily not exceed five years.

Note 3:- The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of the receipt of applications.
